Your Individual or Family Health Coverage in 2016

For individual members only! If you have Health Republic insurance through your employer, this section does not apply to you.

If you have **individual** or **family insurance** that is *not* through your employer, you need to be aware that it will change each year, regardless of which insurance company you use. Sometimes the plans will stay the same but change in price. Sometimes plans will be discontinued. Regardless, you'll always be able to make a decision to change for new insurance coverage effective January of each calendar year. Shopping opens each year during the federal Open Enrollment period. So, for 2016 you need to know:

- 1. Open Enrollment starts on **November 1, 2015**, for plan coverage that starts on **January 1, 2016**.
- 2. Notice of discontinued plans for 2016 have been sent to you via mail. Please do not hesitate to call us if you have any questions or want to discuss options for 2016. Information regarding the discontinuation of plans can also be found in Dawn's blog: www.healthrepublicinsurance.org/changes-for-2016-2015-09-10/
 - If you currently have an **Oregon Standard** or **Catastrophic** Plan, you will be automatically renewed in your current plan for 2016.
- 3. If your plan has been discontinued, you still have the op-tion to stay with us. You will need to enroll in one of our available 2016 plans: Oregon Standard Bronze, Oregon Standard Silver, Oregon Standard Gold, or (if you meet the age criteria) our Catastrophic Plan. Otherwise, you will need to enroll with another insurance company in order to ensure continuous coverage.
